COURSE DESCRIPTION:

The Art Elements and Principles of Design will continue to be a foundation for all artmaking within the classroom. Art 3 is an opportunity to utilize foundational and historical knowledge to begin to start creating artwork using their "artistic voice." Students will have the opportunity to steer their own projects in concept and material. This is a "project based" course. Therefore, it is imperative that students attend all class sessions or they may fall behind in class. Students who wish to continue into the art pathway (AP Art) must receive a "B" or better each semester.

CLASS EXPECTATIONS:

- Respect between individuals. Respect for the materials & tools used in the classroom. Respect for the work of others.
- When the instructor is talking: Listen, make eye contact, and ask questions when appropriate.
- Cell phones or electronic devices must be put away during lecture/demos.
- Food or drinks are not allowed within the classroom. The only exception is water.
- Students must stay in their assigned seats the entire duration of class. Any student out of their seats is at risk of being marked absent and lose participation points.
- Students are expected to do their own work and will neither give nor receive unauthorized assistance (i.e. doing another student's work) on assignments for this class.
- The bell doesn't dismiss you, the teacher does. Please do not wait by the door.

GRADING POLICY

Grades will be based on the timely completion of projects, following directions, neatness of work, creativity and effort, utilizing all class time, as well as several written art critiques. Art 3 students will additionally be graded on several pages within their sketchbook at the end of each grading period. I will provide the sketchbook, as well as guidelines on how I grade the contents.

Students who turn in a project/assignment late will receive a maximum of 75%. If a student is absent, it is the <u>student's responsibility</u> to make arrangements with the instructor to make up any missed work. I only give extensions to artists who have worked diligently inside and outside the classroom to meet the original deadline but due to high quality and care, we are unable to. Extensions are not given to those who waste time and simply want more.

I realize that most students have significant amounts of homework. Homework is extremely rare in my class. Therefore, students will be expected to use class time effectively.

PARTICIPATION POINTS

Participation points are worth 5% of a student's overall grade. During a zoom meeting, these are some key factors I look for from the students:

- Eye contact with instructor
- Nodding in agreement
- Thumbs up/ Thumbs down

- Answering questions
- Responding to polls
